## Promoting good design and enhanced amenity in the Granite City

Aberdeen Civic Society was founded in 1968 with the following objectives:

- To stimulate public interest in, and care for, the beauty, history and character of the city of Aberdeen and its surroundings.
- To encourage the preservation, development and improvement of features of general amenity and historic interest.

The Society pursues these aims by means of illustrated lectures (many of which count towards CPD requirements), discussions, visits and walkabouts for members. The Society published the very successful booklet, Archibald Simpson, Architect of Aberdeen 1790-1847.

The Society has always had close ties with Aberdeen City Council, and its Planning Department in particular. Indeed, our very first chairman was also the head of the then Planning Service.

An important feature of the Society's work is its

Awards and Commendations Scheme. Through this, encouragement is given to those who have added to the amenity of the city by means of new buildings or the restoration and preservation of old ones, or by carrying out other projects which enliven and enhance the environment. The Society keeps itself informed on applications for planning consent made to the City Council. While not confining its interest to Conservation Areas and Listed Buildings, it is particularly concerned with decisions regarding these. It submits encouraging comments and suggestions and lodges objections when the proposals are considered to be detrimental to the city.
